## ORDER NUMBER

WHEREAS, the West Jackson County Utility District seeks to acquire real property on which to construct District infrastructure;

WHEREAS, pursuant to Mississippi law, acquisition of real property requires the establishment of Just Compensation; and

WHEREAS, West Jackson County Utility District has identified approximately .05 acres of real property (hereinafter, "the Property"), more specifically identified in the attached appraisal summary, that will be acceptable for construction of a said infrastructure; and

**WHEREAS**, Mississippi Code Annotated Section 43-37-3 provides the process for acquisition of real property and requires a public entity to obtain an appraisal before the initiation of negotiations; and

WHEREAS, the District has obtained an appraisal of the parcel at issue, a summary of which is attached herein and which has been delivered to the property owner; and

WHEREAS, based on the appraisal, West Jackson County Utility District finds it is in the best interests of the District to establish Just Compensation for the above property in the amount of \$5,800.00; and

WHEREAS, the Board finds that the amount of \$5,800.00 is equal to or less than the fair market value of the Property; and

WHEREAS, in partial consideration of this transfer, the current owner has requested a land swap, and wishes to acquire .10 acres of real property currently owned by the District (hereinafter, "swapped Property"); and

WHEREAS, West Jackson County Utility District has obtained an appraisal of the swapped Property, a summary of which is attached herein and which has been delivered to the property owner; and

WHEREAS, based on the above appraisal, West Jackson County Utility District finds that the fair market value of the swapped Property is \$14,000.00; and

WHEREAS, the owner of the Property has agreed to pay to the District the difference between the fair market value of the Property and the swapped Property, which amounts to \$8,200.00, in order to complete the transaction;

**IT IS HEREBY ORDERED** by the West Jackson County Utility District, that "Just Compensation" for the Property in the amount of \$5,800.00 is hereby established.

**IT IS FURTHER ORDERED** that the fair market value of the swapped Property is hereby established at \$14,000.00.

**IT IS FURTHER ORDERED** that accepting a cash payment of \$8,200.00 as the difference between the values of the relevant properties is in the best interest of the District.

IT IS FURTHER ORDERED that the herein described land swap, in addition to payment of the difference in fair market values is hereby approved.

IT IS HEREBY ORDERED by the Board of Commissioners that the General Manager is authorized to execute any and all documents required to initiate and close the sale of this property.

IS FURTHER ORDERED that Bordis & Danos, PLLC is authorized to conduct the closing.

IT IS FURTHER ORDERED by the Board of Commissioners that, if the current owner of the Property rejects the above arrangement, the General Manager and Board Attorney are authorized and directed to proceed with acquisition of the property by eminent domain litigation.

IT IS FURTHER ORDERED that the General Manager is authorized to execute and any and all additional documentation required for this purpose.
