RESOLUTION AND ORDER TO CONDEMN

To accomplish this project, the District finds it necessary to acquire for public use an easement across property described as PIDN 03611100.000 from Charles T. Newsom, Jr., et ux, or their successors in title, and/or other parties interested in said property, consisting of 3,073 sq. ft. as shown on the plans for said project, which plans are made a part hereof by reference.

Being unable to agree with the owner(s) and/or other parties interested in said property, the District, after solemn due consideration, does hereby declare said property necessary for the public use, and orders that it be condemned. Further, the District authorizes and requests its attorneys and/or other necessary professionals to institute any and all condemnation proceedings necessary to acquire the property described herein for the public use referenced.
